
Chaperone/Temporary Guardian

Rules and Expectations for Participants

1. Youth Sobor participants are expected to conduct themselves as Orthodox Christians living in the image of our Lord and Savior Jesus Christ. If a participant's behavior is found to be unbecoming of an Orthodox Christian, their participation in the Youth Sobor may be jeopardized.
2. Youth Sobor participants are similar to those of the Regular Sobor in that they represent their parish and are welcomed to share their opinions and ideas in order to help develop the ideas for the future of our Holy Ukrainian Orthodox Church.
3. Youth Sobor participants should adhere to a professional dress code while attending the Youth Sobor Sessions and should have appropriate dress for all Liturgical and Prayer Services. Dress for social/fellowship events may be casual but should also reflect the modesty of an Orthodox Christian. Possible suggestions for females would be; knee length skirts, blouses, and head coverings (these could be borrowed from your grandmother if necessary). Possible suggestions for males include; dress slacks, dress shirt (polo, button up, collared shirts), tie is optional.
4. Under no circumstances are Youth Sobor participants to consume or be in possession of illegal drugs/substances, or alcoholic beverages. Youth Sobor participants found with any of these items may be expelled from the Youth Sobor and the proper authorities may be contacted.
5. Youth Sobor participants may not be in possession of any kind of firearms or weapons.
6. Youth Sobor participants must attend and participate in all scheduled Youth Sobor events. With the permission of the attending Chaperone, participants may leave a scheduled event but must sign-out from the event with official Youth Sobor Volunteers and with written permission from the Chaperone.
7. Youth Sobor participants are to inform their Chaperone of their whereabouts at all times.
8. Youth Sobor participants are expected to attend all Liturgical Services.

Expectations for Chaperones/Temporary Guardians

1. Chaperones should know of their charges whereabouts at all times.
2. Chaperones are solely responsible for their charges when they are not participating in officially scheduled Youth Sobor Activities.
3. Chaperones who are sharing accommodations with their charges agree to adhere to the above stated Youth Sobor Rules and Expectations while in their rooms.
4. Chaperones will notify official Youth Sobor Volunteers if they will be checking their charges out of Youth Sobor Activities.
5. Chaperones are responsible for their charges to abide by the set rules and expectations listed above.
